Definitions

When applying these terms and conditions, and the agreements which refer to these terms and conditions, the following terms and definitions apply.

Table 1. When applying these terms and conditions, and the agreements which refer to these terms and conditions, the following terms and definitions apply.

Terms	Description
Subscription (notification)	Regularly recurring delivery of specified geodata products.
Subscription fee (notification fee)	License fee which is paid for the right to receive automatic updates to geodata products, at certain intervals or upon order. Subscription fee for real property information is also known as a notification fee.
Administrative fee	Administrative fee is charged for orders of geographic information that require manual handling.
Usage category	Division of usage according to geodata operations; public usage, commercial end usage, non-commercial usage (non-profit and private usage, respectively), use for research or education.
Notification	Regularly recurring delivery of updated data.
Direct access service	A service which allows direct queries to read or retrieve one or more objects.
Distribution	The provision of geodata in unprocessed or processed form, including grants of rights (licence) for the use of geodata or for the use of a product/service including geodata.
Personal use	Individual, private use.

Terms	Description
One-time fee	One-time fee, license fee which is paid at a single point and confers and unlimited right of use for the period in question.
External use	Sharing with or publication/disclosure for a party other than the legal or natural person who holds the license agreement for usage.
Fixed fee	Fee which does not change, for example as a result of changes to geo-graphical area or number. Fixed fees can be charged at a single point, annually or at other intervals.
Basic real property information	Real property-related information in accordance with the Real Property Register Act (2000:224) and information in registers that are maintained in accordance with the Ordinance on maintaining a register of joint property management associations (1993:1270) and the Mortgage Certificates Register Act (1994:448).
Research, education and cultural activities	Usage within operations that are concerned with education and non-commercial research, as well as cultural and library activities.
Derivative product	Product made by processors that contain, or whose production is dependent on, Lantmäteriet's geodata.
Contractor's commitment	Agreement regulating the licensee's right to temporarily share their license with consultants, contractors etc., for a very specific task.
Geodata	Comprehensive term referring to data that describes features, including their geographical location.
Geodata product	Selection of Lantmäteriet's reference data that has been copied, possibly processed and delivered according to a standardised specification.

Terms	Description
Geodata service	Digital basic service with a machine-to-machine interface that allows access and handled geodata.
Basic geographic information	Information about features or phenomenon that are connected to a position in relation to the earth's surface.
Base fee	Fee according to LMFS. The base fee is used to calculate the license fee
Reference data	Term information concerning real property, to- pography, images and geodesics that Lantmäteriet as a government agency is charged with managing and coordinating.
Non-commercial use	The use of geodata products by non-profit organisations and individual persons for their own, non-commercial purposes.
Internal use	Use within a company, organisation or private use.
Commercial end-customer use	Operations run for commercial purposes in various forms of association (joint-stock company, limited partnership, general partnership, partnership firm, co-operative association, European economic interest grouping, certain foundations etc.).
Lantmäteriet's geodata service	Service which provides access to and handles Lantmäteriet's geodata.
Lantmäteriet's Inspire service	Geodata service which meets the requirements of the Inspire directive.
Delivery format	Format in which a geodata product is provided.
License fee	Calculated fee which licensees must pay to be authorised to use Lantmäteriet's geodata products.
License agreement	Agreement which regulates the parties' provision/use of geodata products. License agreements can be established with commercial

	processors or end customers. License agreements with end customers are also known as end customer agreements.
License provider	Lantmäteriet or party representing Lantmäteriet.
Licensee	The party that has acquired rights concerning geodata products through a license agreement with Lantmäteriet or party representing Lantmäteriet. The rights may include the right to provide geodata products to end customers, the right to produce derivative products that contain Lantmäteriet's geodata products, or the right to use geodata products for internal, private use.
Licensing terms and conditions	Terms and conditions for the licensee's use of geodata products.
LMFS	Lantmäteriet's provisions regarding fees for basic geographical information and real property information – Geodata – as well as geodesics and mortgage bonds.
Machine-to-machine	Interface/contact point between systems.
Machine-to-human	Interact/contact point which can be used directly by a person. This includes graphical user interfaces.
Download service	Basic service which enables downloading and, when possible, direct access to copies of geodata products or parts of geodata products.
Public sector use	Use for the carrying out of public tasks, assuming that they cannot be described as business operations that take place on a competitive market.

Terms	Description
Partner	Commercial Further Processor who has entered into a partner agreement with Lantmäteriet. A partner has the right to sign agreements concerning Lantmäteriet's geodata with another Commercial Further Processor (VF2) on behalf of Lantmäteriet.
Personal data	Personal data means any information relating to an identified or identifiable natural person. An identifiable natural person is one who can be identified, directly or indirectly, in particular by reference to an identifier. This can, for example, be information about a person's name and social security number (direct) or about a real property designation, a centroid with unique id, co-ordinates and mortgages (indirect).
Private use	The use of geodata products by non-profit organisations and individual persons for their own, non-commercial purposes.
Slutanvändning	End use means the use of unprocessed or processed geodata for internal use/own use, i.e. in the ordinary measures that are part of the internal administration or operation of the end customer's business or organization.
End customer	User who, through a license agreement with Lantmäteriet or party representing Lantmäteriet, acquires the right to use unprocessed or processed geodata for internal or private use. (Also known as licensee).
End customer agree- ment	Agreement which regulates the end customer's use of geodata products. (Also known as license agreement).
End customer terms and conditions	End customer terms and conditions for public sector use, commercial end customer use, non-commercial use, and research and education.
Initial fee	Fixed fee which is charged when delivering geodata products and in connection with handling of consent.

Terms	Description
Technical description	Description of a geodata product's interface and functionality.
Term catalogue	Document containing descriptions of the delivery format in the real property register or real property price register, with object models and terms.
Transaction fee	Fee for queries or answers to queries in a service, application or system containing geodata.
Third party	Third party refers to an external party which does not match the definition of a contractor.
Unique visitors per week	Fee for unique visitors per week are only applied to geographical in-formation. Unique visitor refers to a web browser at a domain address or website. The fee is paid for each unique visitor at the domain address or website, regardless of the type of information that the visitor requests or uses. This means that visitors do not need to open a map or image, or make a search query to count as a unique visitor.
Contractor	A consultant, contractor or other person who carries out a task limited in time and scope, for example development of an application, on behalf of the licensee.
Commercial further processor (VF)	A natural person or a legal body who, through a license agreement (Agreement on Commercial Further Processing) with Lantmäteriet, has acquired one or several rights concerning processing and distribution of geodata.
VF2	Commercial Further Processor who, through a partner, acquired one or several rights to produce derived products containing Lantmäteriet's geodata and to distribute them
Viewing service	Basic service which allows users to acquire background images or documents for viewing in the customer's system or applications, for example through WMS queries.

Terms	Description
Annual fee	License fee that is paid annually and in advance. The annual fee is paid as long as the service is in use. The fee grants right to use the service and receive updates.
Access right	The way in which a geodata product becomes accessible to users.
Purpose of evaluation	The evaluation required for provision of personal information from the real property register in accordance with the Real Property Register Act (2000:224) and the regulation (EU) 2016/679 of the European parliament and of the council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free move-ment of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) with supplementary Swedish legislation.
